Affordable dental care

Beautiful and healthy teeth cannot be taken for granted. And statutory health insurance does not reimburse all the costs of dental care. Dentalia Plus is the perfect addition to your Helan orthodontic benefits. With Helan's benefits, you get reimbursed up to 1050 euros for children's and adolescent's braces (up to the age of 22) on top of your statutory reimbursement. Add an additional Dentalia Plus reimbursement and even the most expensive braces remain affordable. Add an extra Dentalia Plus reimbursement and even the most expensive brace remains affordable.

And dental insurance provides even more. You will not only receive reimbursements for orthodontics, but also for dental prostheses, implants, periodontology, preventive and curative dental care. Dentalia Plus therefore provides lifelong protection against expensive costs of dental care for your whole family.

Get up to 1,250 euros per year reimbursed

Up to 100% for preventive dental care

You will be reimbursed in full for treatment that detects and tackles developing dental problems.

- Oral examinations
- Gum checks (periodontal index)
- Removing tartar
- Sealing grooves and pits
- Preventive consultations

Up to 80% for curative dental care

You will be reimbursed 50% or 80% for technical treatment that improves compromised oral health, depending on your preventive behaviour*.

- Filling cavities
- Removing teeth
- Oral X-rays

Up to 60% for orthodontics

You will be reimbursed 60% for treatments to correct abnormal positioning of teeth using a brace or blocks for children and adults. This also includes a night guard for teeth grinding.

Up to 80% for prostheses, implants and periodontology

For equipment to replace teeth and treatments for gum disease, ligaments or tooth sockets, you will be reimbursed 50% or 80%, depending on your preventive behaviour*.

* Preventive behaviour: you will receive the highest reimbursement for this treatment if you also received a reimbursement for dental care in the calendar year prior to the treatment. So plan a visit to the dentist for a check-up every year.

About the maximum reimbursement

There is a certain ceiling for all reimbursements. This is a maximum amount that you can get back each year. The maximum annual amount is considered per membership year and not per calendar year.

About the minimum waiting period

Every insurance policy has a waiting period. This is the period from when you join, which you must bridge before you can be reimbursed. Not much fun if you need urgent dental care exactly then. That’s why Dentalia Plus cancels the waiting period if you have an accident. If you already have similar insurance, the waiting period expires.

- No waiting period in the event of an accident.
- 6-month waiting period for preventive, curative and periodontal treatment.
- 12-month waiting period for orthodontics, prostheses and implants.

You can join **up to the age of 64** if you are a Helan customer and are up to date with your contributions to the health insurance fund. You as a parent and your dependent children join together.
